# Who is Nicole Lamb-Hale?

On November 18, 2009 President Obama nominated Nicole Lamb-Hale to be the Assistant Secretary of Commerce for Manufacturing and

Services. Her only apparent connection to manufacturing is her bankruptcy practice.

While the program had reported to the federal government in its application to have one of six federal empowerment zones that private entities had pledged \$1.97 billion to the project, the Detroit Free Press claimed that its review of pledge letters came \$265 million short of that total. Ms. Lamb-Hale's answer was that they did not have time to itemize them.

"It's not like we had a database or a computer printout by category," said Nicole Lamb-Hale, a lawyer with Dykema Gossett who helped the compile the commitment figures. "We didn't have that kind of time. The commitments were coming in at the last minute, within the last week." Fn.3.

Detroit insisted that they had \$1.97 billion, though they could not itemize the pledges and the Clinton Administration still awarded them the federal empowerment zone.

In a 2001 report by Robin Boyle and Peter Eisinger of Wayne State University, the Detroit Empowerment Zone is held up as the model of the failure of the program. Fn.4.

### Foley and Lardner L.L.P., a National Law Firm

Ms. Lamb-Hale was the first African-American woman to hold such a high profile position with a Detroit law firm. While there she focused on bankruptcy law and was a part of F&L's Automotive Industry Team. The firm represented several creditors (suppliers) of GM and Chrysler during their bankruptcy. Her father, Rawleigh Lamb, was an executive with Chrysler in the 1990's. She represented Pilot Industries, Inc, and Medifacts International. She also represented the Wayne County Airport Authority. Shortly before she decamped to the Counsel's office of the Commerce Department, Delta Airlines and the Airport Authority announced that they were talking about \$100 million dollars in runway and taxi-way improvements at Detroit Metro.

"The federal government will pay for 75 percent of the work, and the authority will bear the remaining 25 percent, and its budget comes from landing fees provided by the airlines." Fn.5.

Ms. Lamb-Hale was a classmate and friend of Pres. Barack Obama at Harvard Law and graduated with him in 1991. She decided to go to law school in order to help African-Americans after watching the March on Washington, but ended up in bankruptcy law, claiming:

"Bankruptcy represents the last general practice that involves business transactions and litigation... Through this work you get an appreciation for what businesses need and identify telltale signs of trouble." Fn.6.
